# CENTRAL GENERAL DIRECTORATE LEGISLATIVE AND INSTITUTIONAL AFFAIRS THE DIRECTOR

#### Given:

- the application received on January 23<sup>rd</sup> 2009, con la quale il sig. Stefano Possati, as Chairman and legal representative of the Association named "Italian-American Association of Culture and Studies "Luciano Finelli" Friends of the Johns Hopkins University" in brief "Friends of the Johns Hopkins University", based in Bologna, requests the acknowledgement as legal status of legal entity of the Association, determined by the registration in the regional Registry of legal entities;
- the articles of association written in Bologna on January 28<sup>th</sup>, 2002 by dr. Sandro Serra, notary in Bologna, index no. 48,797, file no. 6,043 and the relevant articles of association, as modified in May 26<sup>th</sup> 2009, by the same notary, index no. 64,542, file no. 9,605, from which the Association purposes and organization structure can be drawn;

Ascertained that the Association is a non-profit organization and its purposes are the development and support of cultural activities, devoting particular attention to the organization of language courses, the development of teaching methods and the setup of research groups;

Acknowledging that the assets of the association consist of the awarded association revenue as well as the assets indicated in art. 14 of the articles of association;

Having verified that the initial association revenue, as it results from the report on the economic and financial statement of the Association - attached to the application for acknowledgement of legal status – is suitable for the pursue of the stated objectives;

## Given:

- that the Association objectives will be pursued within the Region Emilia-Romagna and that the association operates within the areas of culture and education;
- the opinion expressed pursuant to the first subparagraph of art. 6 of the Regional Law no. 37/01, by the Directorate General for Culture, Training and Employment. Culture, Sport and Youth Project, with a note of February 17th, 2009, index no. NP/2009/2456;
- that the aforementioned documentation is kept in the records of this Directorate General;
- Considering that the present proceeding has been suspended from February 9<sup>th</sup>, 2009 to July 7<sup>th</sup>, 2009 in order to allow the acquisition of further document

Therefore the articles of Association were approved and consequently the legal staus of the association is recognized, through the registration in the Regional Registry of legal entities;
